Purposes of processing:

- Dispatch of invitations to events held by the Freunde des Max Beckmann Archivs e.V.
- General information about the Freunde des Max Beckmann Archivs and the artist
- Event-related letters from the Freunde des Max Beckmann Archivs
- Execution of the membership contract and the life of the association

For this, we need your name, address and an email address (if available). If you would like to set up a direct debit, we need your bank details.

Legal basis for the processing

The execution of the membership contract, which results from your declaration of membership, is governed by Art. 6(1)(b) GDPR, and all other processing is carried out in accordance with Art. 6(1)(a) GDPR, as we require your consent for this.

Recipient of your personal data:

Since the Freunde des Max Beckmann Archivs do not have their own business premises, their office is housed in the offices of the Bavarian State Painting Collections. It is therefore essential that your data is also processed by the Bavarian State Painting Collections for organisational reasons, such as the provision of the IT infrastructure. However, close attention is paid to ensuring that unauthorised third parties do not gain access to your personal data.

Duration of data processing

Your personal data will be processed on an ongoing basis during your membership. Once your membership has been terminated, we must retain the financial records for a period of 10 years after the end of the calendar year in which the membership was terminated, for tax reasons.

Your rights

We would like to draw your attention to the existence of your right of access to the personal data concerned vis-à-vis the data controller and to rectification, erasure or limitation of processing, your right to object to processing and your right to data portability;

where the processing is based on Article 6(1)(a) or Article 9(2)(a), the existence of your right to withdraw consent at any time without prejudice to the lawfulness of the processing carried out on the basis of the consent until such time as it is withdrawn;

the existence of your right to lodge a complaint with a supervisory authority.
